### 2. Competition Period

- Championships Period: April 21 – May 1, 2011
- Competition Period: April 24 – 30, 2011
- Arrivals: April 21- 22, 2011
  - **All teams must arrive no later than April 22**
- Departures: May 1, 2011

#### **4. Competition Venue**

- Name: Kepez Belediye Kapali Spor Salonu
- Location: Antalya, Turkey

#### **5. Key Competition Rules**

The Championships will be held following AIBA Technical & Competition Rules

##### **A. Junior Championships:**

- Boxers who were born between January 1, 1995 – December 31, 1996 are eligible to participate (15 – 16 ages)
- Junior Championships will be staged in 13 Weight Categories:
  - 44 – 46kg, 48kg, 50kg, 52kg, 54kg, 57kg, 60kg, 63kg, 66kg, 70kg, 75kg, 80kg, 80+kg

- B. Youth Championships:
- Boxers who were between January 1, 1993 – December 31, 1994 are eligible to participate (17 – 18 ages)
  - Youth Championships will be staged in 10 Weight Categories:
    - 45 – 48kg, 51kg, 54kg, 57kg, 60kg, 64kg, 69kg, 75kg, 81kg, 81+kg
6. **Number of Rounds**
- A. Junior Championships:
- Three (3) rounds of two (2) minutes, one (1) minute rest between rounds
- B. Youth Championships:
- Four (4) rounds of two (2) minutes, one (1) minute rest between rounds
7. **Scoring System**
- A. The new approved AIBA Scoring System will be in use meaning that for the awarding of points, the average will be taken of the three (3) Judges scores which are the closest together instead of the accepted points within one second timeframe
- B. AIBA sent the description of this new system to all National federations in January and will send the computer CD-Rom to replace the existing system at the beginning of March
8. **Referees & Judges**
- All Referees & Judges will be selected by AIBA - National Federation are not allowed to send any R&Js
9. **Registration**
- A. Boxers:
- AIBA affiliated National Federations can send only one (1) boxer in each weight category
  - One (1) reserve boxer per weight category may be entered in the final entry form. It is also permissible for a nation to substitute one Boxer for another at any time up to the close of the General Weigh-In and the medical examination, provided that the substitute Boxer has been entered as a reserved one for that weight category, or any other weight category
  - All other cases of substitution shall be finalized the day before the General Weigh-In

**B. Number of Team Officials:**

- Each team can have the following number of officials in its delegation:
  - 1 - 3 boxers: 2 coaches
  - 4 - 7 boxers: 3 coaches
  - 8 -13 boxers: 4 coaches
- In addition, each team may be accompanied by one (1) team manager, one (1) team doctor and one (1) physiotherapist
- Only coaches and boxers are allowed to enter the boxers' locker room

**10. Requirements**

**A. All Boxers must be registered within the AIBA Database and bring to the General Weigh-In:**

- Record Book with annual medicals duly completed
- Passport
- Accreditation Card

**B. Each Team Delegation must bring the following:**

- National flag 1x 1.50 m – every participating country
- National anthem (on MP3 or CD) – every participating country

**C. Boxer's Uniform:**

- Each boxer must bring two set of uniforms
- The colors of these uniforms must be completely different

**11. Boxing Equipment**

The LOC will provide AIBA approved and licensed boxing gloves, headguards and hand bandages to all boxers for all bouts. Both boxing gloves and headguards are compulsory official items which all boxers must wear, not their personal ones

**12. Transportation**

**A. Airport Reception:**

- All participants will be welcomed at the Antalya Airport

**B. Ground Transportation:**

- There will be a welcome desk to guide all teams to the ground transportation
- The LOC will provide local transportation between Hotel, Venue, and Training Venue(s) during the Championships Period
- The LOC will also provide local transportation for all departures



### 13. Accommodation for Team Delegations

#### A. Room Rates for Team Delegations:

- For double occupancy (2 persons per room)
  - US\$ 50 per person, per day, including 3 meals
- For single occupancy (1 person per room)
  - US\$ 70 per person, per day, including 3 meals

#### Subject to room availability:

- *Extra Team Officials:*
  - US\$ 120 per person, per day, including 3 meals

#### B. Payment of Hotel Room Charges:

- All delegations must pay the full room charges in advance at the time of check-in
- All delegations will not be allowed to receive accreditations and hotel room keys if they do not clear the payment of full hotel room charges

#### C. Check-In and Check-Out:

- The room rates provided for the competition only apply from April 28 to May 8, 2011
- Team Delegations choosing to arrive earlier and/or stay longer than Championships Period must pay the room rate of US\$ 120 per person, per day, including 3 meals

#### D. Extra Team Officials:

- No Extra Team Official is allowed to stay in the Team Delegation Hotel
- LOC assistance can only be given in finding rooms in a different hotel than the Team Delegation Hotel

### 14. Insurance

All participants are requested to get their own travel and medical insurance. In addition, the LOC will provide a liability insurance only in the Competition Venue for all participants

### 15. Medical Care

The LOC will provide medical care and first-aid during the entire event to all participants who suffer from a sport injury (contracted during the event)

**16. Doping Control**

Doping control shall be conducted in accordance with the AIBA Rules and following the World Anti-Doping Code under the supervision of the AIBA Medical and Anti-Doping Sub-Commission

**17. Medals**

Gold, Silver and 2 (two) Bronze Medals will be awarded along with diplomas to the winners in each weight category

**18. Training Facility**

The LOC will provide required training facilities (information will be provided upon arrival)

**19. Commitment of Participation Form**

The deadline to send your Commitment of Participation Form is Tuesday, February 15, 2011 at the latest:

- Any registration received after February 15, 2011 Lausanne midnight (GMT +1) will not be taken into consideration
- The Commitment Participation Form must be fully completed and signed by the National Federation's President or Secretary General

**20. Final Registration Form**

A. The deadline for final registration is Monday, March 21, 2011

B. Final registration forms will only be sent to those National Federations that commit their participation according to the deadline as mentioned under N° 19

**21. Visa**

The LOC will grant assistance to all delegations on VISA matters
